Background Summary: The original budget was adopted on September 21, 2015 and a Fire Impact Fee budget was not created because at the time it was not anticipated that any new funds would be generated

Issue: Thus far this fiscal year, we have permitted (12) new single family homes resulting in additional Fire Impact Fees. Staff anticipates collecting \$3,000 by the end of the fiscal year. The amended budget accounts for the new revenue.

Budget Amendment – Fire Impact Fee Fund (150)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, PURSUANT TO SECTION 29 OF THE CITY CHARTER AMENDING THE BUDGET FOR THE 2015-2016 FISCAL YEAR BY INCREASING AND /OR DECREASING THE AMOUNT OF REVENUES AND EXPENDITURES WITHIN THE FIRE IMPACT FEE FUND, RECEIVED AND INCURRED AFTER THE ORIGINAL BUDGET WAS APPROVED; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the original budget was approved on September 21, 2015, and

WHEREAS, a budget for the Fire Impact Fee Fund was originally not set up, and

WHEREAS, a line item for police impact fees was not funded, and

WHEREAS, this amendment funds \$3,000 for fire impact fees, and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, AS FOLLOWS:

1. The City of Mascotte’s Fire Impact Fee Fund Budget for the fiscal year 2015-2016 is amended as follows:

Fire Impact Fees	-	\$3,000
Additions to Reserves	-	\$3,000

2. If any section, sentence, clause or phrase of this resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, that holding in no way shall affect the remaining portion of this resolution.

3. This resolution shall become effective immediately upon passage by the City Council of Mascotte, Florida.
