Budget Amendment – Police Assessment Training Fund (110)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, PURSUANT TO SECTION 29 OF THE CITY CHARTER AMENDING THE BUDGET FOR THE 2015-2016 FISCAL YEAR BY INCREASING AND /OR DECREASING THE AMOUNT OF REVENUES AND EXPENDITURES WITHIN THE POLICE ASSESSMENT TRAINING (PAT) FUND, RECEIVED AND INCURRED AFTER THE ORIGINAL BUDGET WAS APPROVED; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the original budget was approved on September 21, 2015, and

WHEREAS, a budget for the PAT Fund was originally not set up, and

WHEREAS, it is anticipated that we will bring in \$1,000 in new revenue, and

WHEREAS, it is also anticipated that we will spend \$2,500 of the Fund's reserve balance, and

WHEREAS, this budget was created to allow for a total of \$3,500 in police officer training by way of school and book purchases,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, AS FOLLOWS:

1. The City of Mascotte's PAT Fund Budget for the fiscal year 2015-2016 is amended as follows:
